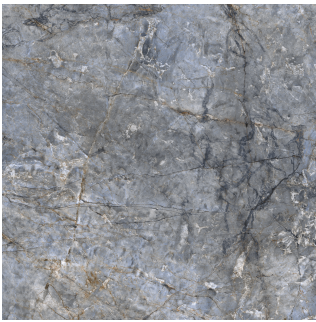

Las dimensiones, el tono y peso de las piezas presentan variaciones normales por el proceso de cocción. **A, EN.** Product manufactured for Cerámica San Lorenzo SAC, according to the requirements of the INTERNATIONAL Standard ISO 13006: "Dry -Pressed Ceramic Tiles", Annex G (Normative), Table G.1- Requirements for dry -pressed ceramic tiles-Group BIa, Ev ≤ 0.5%. The dimensions, tone and weight of the pieces present normal variations due to the firing process.

B, ES. 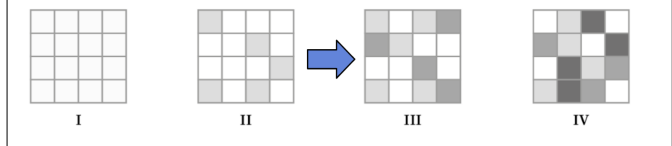
